#### Member Eligibility and Signature

By signing in the space provided below the applicant acknowledges that the eligibility for CREW Vancouver membership may be reviewed by the Board of Directors on an annual basis and that to remain a member the individual must continue to meet the eligibility requirements for membership as follows:

- 1) The individual must have the appropriate level of professional commercial real estate experience as follows:
  - a. **Full Member** - at least five years' experience in a qualified CRE category
  - b. **Associate Member** - more than two, but less than five years' experience in a qualified CRE category
  - c. **Affiliate Member** – members employed in a field related to CRE which benefits, supports or supplies a service or product to CRE professionals (eg. contractors, furnishings, landscaping, marketing/PR, etc.)
- 2) The individual must be currently involved in a substantially full-time professional position, the primary responsibilities of which are in one or more qualified commercial real estate categories;
- 3) The individual must maintain the highest of professional and ethical standards; and
- 4) To maintain membership, the individual's CREW Vancouver membership account must be in good standing.
